Asbestos update at Park North basement - Park North has asbestos in the area around the pipes and insulation - air monitoring before, during and after. Things in the basement have to be sanitized and mold removed.

Whole abatement of basement – the cost is \$61,745 – Boyle. Building will be closed Thursday, 9/25 and Friday, 9/26 so the building can reopen on Monday. The length of warranty is lifetime of no more asbestos.

Boilers in the high school – the basement in the high school flooded in the last huge rain storm. Pumps failed in last storm due to high rain. The insurance company will be contacted. Check with boiler company. Check on how old is sump pump. Do we have the right sump pump?
