President Dodd led the audience in the Pledge of Allegiance and asked the Community and the Board to please observe a moment of silence in respect to Mark Engler of Park Avenue Memorial Elementary School who passed away this summer and the gun violence in El Paso, Texas and Dayton, Ohio.

PRESENTATIONS

Barbara Graziano, Western Suffolk BOCES reported on the Annual Enrollment Study which discussed trends in population.

Gary Scheide of BBS and Joseph Moisa of Park East updated the Board on the Administration Building Masonry Reconstruction; the Edmund Miles Middle School Window Replacements; the Park Avenue Memorial Elementary School Capital Improvements; the Amityville Memorial High School Additions and Alterations Capital Projects, the Northwest Elementary School, Additions and Alterations and Northeast Elementary School Capital Improvements.

Brendan Broderick and Ed McGuire of Broderick and Associates updated the Board on the removal and replacement of the Park Avenue gym floor.

Ms. Santos asked if the floor will be ready for the School opening in September. Mr. Broderick replied that the floor would not be ready.

Dr. Fulton asked what is the time frame for the concrete to be broken up and dismantled, and when is the new concrete slab being poured. Mr. Broderick responded that it would be 2 to 3 weeks.

Andrea Pekar, Assistant Superintendent for Curriculum & Instruction, reported on ongoing changes with the New York Standards on Curriculum and Testing Programs. The State is moving from Common Core Standards to Next Generation Standards. We as a District are staying on top of the changes.

Motion to open Public Hearing to adopt the District-Wide School Safety Plan made by Ms. McVeety Pawlewicz; seconded by Ms. Bernard-Handler. Discussion: None. Motion Carries: 7 Yes; 0 No; 0 Abstain

Sydney Freifelder, Interim Assistant Superintendent for Finance & Operations, provided an overview of the District Wide School Safety Plan as part of the Public Hearing.

Juan Leon, Trustee, asked if the district still had people sign in to the School Board Public Meetings. Dr. Kelly responded that the process is still in place.

Toni Bean, asked how long it would take for a Security Guard to address a situation? Dr. Kelly responded that the Security Guards work with the Administration when there are situations or issues. Security Guards have communication devices and immediately summon an Administrator.

Mercedes Reed asked if the Security Guards who are hired are going to be armed. Dr. Kelly responded that we do not employ armed guards. Ms. Reed also asked what role the guards played in providing security in the buildings. Dr. Kelly responded that the security guards do not handle the work of law enforcement. Ms. Reed also asked if a student brought in arms would the security guard be able to handle that situation. Dr. Kelly responded that she could not discuss a buildings safety plan, those are confidential and are not shared to insure the safety of the students, staff and building.

Juan Leon stated that the plan has open spots for a Board Member and others to be determined. He asked if they were going to adopt the plan without the names. Dr. Kelly stated that it is up to the Board to decide. Sharon N. Berlin, Esq. responded that we are approving the plan and the ATA will appoint the person that they want to be on the

committee. Ms Santos stated that the plan is not ready, so we should table it. Dr. Fulton also stated that we should take another look at the Safety Plan.

Mr. LaForest wanted to know about testing the mercury levels in students and if there was a notification sent out and how the cost of medical exams are being covered. Dr. Kelly responded that the community was notified and several letters went out. We have not had any requests about medical testing.

Toni Bean stated that she had received a letter from the district about the gym floor and it did not mention anything about medical testing. Ms. Bean asked if the Pre-K Curriculum was available to the public. Dr. Kelly responded that the presentations are on the District Website and if anyone wanted to see the materials she would make them available. Ms. Bean also asked about the transition from Common Core and when will it take place. Dr. Kelly explained that the entire state was transitioning to the new Next Generation Standards.

Toni Bean commented on salary increases for administrators and asked why the board was approving a 3% salary increase when they currently have a contract. Dr. Kelly responded that they are nonaligned staff and are receiving the same increase as the other administrators.

Michael McDonald asked if there is a math program starting after the summer school program. He also asked for a brief outline on what will be in that program. Dr. Kelly responded that this is a program to give students a boost and prepare them for Algebra.
